Prior Authorization Toolkit

In February 2024, HHS granted **enforcement discretion** to encourage rapid adoption of **FHIR-based Prior Authorization APIs**—despite this flexibility, the **January 2027 deadline for full compliance** remains in place.

Datalite enables rapid, secure, and cost-effective compliance with this CMS mandate.

1) Modernize Data Standards: FHIR to Replace X12/EDI 278

Datalite's Prior Auth Toolkit uses your existing data and systems, including CSV, JSON, RDBMS, and X12/EDI systems—to power CMS-compliant FHIR APIs without requiring legacy system changes.

Our toolkit often meets these new requirements without disrupting legacy data and systems. By converting and accessing legacy data in a FHIR format but leaving legacy systems in place, Datalite enables you to modernize in a phased approach, while still meeting deadlines.

2. Automate Workflows & Meet Metrics Requirements

In addition to API-based workflows including

- Determining when prior authorization is required
- Supporting submission of clinical documentation
- Enabling Bi-directional exchange of requests/responses to support these workflows

- Approval/denial rates, Time to decision, Denial reasons and other metrics
- Required prior authorization metrics must be publicly posted by March 31, 2026—months before the January 2027 API mandate.
